Subject: Perpetual California Regional Mental Health Systems Coalition (JPA) Agreement

RECOMMENDATIONS: The Mental Health Department is advising the Board of a current perpetual agreement (JPA) with the California Regional Mental Health Systems Coalition ("Coalition") and is recommending that the Board:

- 1. Approve continuation of the perpetual agreement; and
- 2. Authorize the Purchasing Agent to encumber sufficient funds through June 30, 2007, to make the required contributions to the JPA as defined in Section 7.2 of the JPA agreement and as approved in the JPA Quarterly Meeting Minutes dated July 26, 2006.

REASONS FOR RECOMMENDATIONS: The Mental Health Department is a member of a nine-county Coalition (JPA) approved by the Board of Supervisors on September 27, 2005. The Coalition was created to evaluate various electronic billing and clinical management software systems, to act on behalf of the counties to contract with the chosen vendor, and to provide ongoing monitoring of the contract and communication with the vendor. Participation in the Coalition has reduced the Department's costs for evaluating and purchasing the software system and allows the Department to benefit from on-going technical expertise funded by this multi-county agreement. As the contracting entity, the Coalition is responsible for making payments to the vendor, and the represented counties are responsible for contributing their proportionate share of the cost to the JPA.

FISCAL IMPACT: The Department is authorized to expend a maximum of \$204,040. This amount exceeds by 10% the projected costs of \$185,491 to allow for an increase in the number of software licenses purchased during the year as may be necessary.

NET COUNTY COST: None. Realignment funds and MHSA/Prop 63 funds are available to meet this anticipated expense.

ACTION TO BE TAKEN FOLLOWING APPROVAL: Purchasing Agent shall encumber the funds for this agreement and Mental Health shall make payment upon receipt and approval of invoices. Any future changes to terms and conditions of this agreement will be brought to the Board for approval.
