Recommendation

The Auditor-Controller recommends that the Board of Supervisors extend Larry Klaus's consultant contract to provide programming services to the Auditor-Controller's Office and authorize the Board Chairman to sign Amendment I to Agreement for Services #392-S0611 with Larry Klaus, after it has been reviewed by County Counsel and Risk Management.

Reason for Recommendation

The Auditor's Office has several data base programs that are utilized by several county departments. Currently these programs are maintained within our office which require some ongoing maintenanc. Beginning this fiscal year we are converting the reporting data base, commonly referred to as EdCat, to the intranet. Mr. Klaus's expertise will be necessary to assist in this transition.

The proposed fee for the contract amendment is \$15,000.

Fiscal Impact

The cost of the consultant services are included in the FY 2006/2007 budget appropriations.
