Recommendations:

The Department of Transportation recommends the Board of Supervisors:

- Approve the attached Irrevocable Offer of Dedication for road right of way and public utilities easements, and adopt the Resolution acknowledging but rejecting said offer, at this time; and
- 2. Authorize the Chairman to sign said Resolution.

Reasons for Recommendations:

The Department of Transportation has received an Irrevocable Offer of Dedication for road right of way and public utilities easements situated along the centerline of Wood Duck Way, for the subject properties identified as Assessor's Parcel Numbers 046-431-07 and 046-431-08, being more particularly described in Exhibit A and depicted in Exhibit B of the attached Resolution. Said dedication is being made by Lawrence Loftis and Francesca Loftis, and is necessary to meet the condition requirements of Boundary Line Adjustment application #06-0047. The subject properties location lies south of the middle fork of the Cosumnes River, and west of Mt. Aukum Road (E16), in Outingdale.

The Department of Transportation's staff has reviewed said offer and recommends that the Board adopt and authorize the Chairman to sign the Resolution acknowledging but rejecting said offer at this time. Authorization for recording of said offer is pursuant to Government Code Section 7050.


