Recommendation:

- 1. The Auditor-Controller recommends the Board of Supervisors receive and file the attached Report of Special Tax Delinquencies for Community Facilities District No. 1992-1 (CFD 1992-1 Serrano).
- 2. The Auditor-Controller recommends the Board of Supervisors receive and file the attached Report of Special Tax Delinquencies for Community Facilities District No. 2001-1 (CFD 2001-1 Promontory).
- 3. The Auditor-Controller recommends the Board of Supervisors receive and file the attached Report of Special Tax Delinquencies for Community Facilities District No. 2005-1 (CFD 2005-1 Blackstone).
- 4. The Auditor-Controller recommends the Board of Supervisors adopt the attached Resolutions authorizing judicial foreclosure of delinquent special tax installments pursuant to the CFD 1992-1, 2001-1 and 2005-1 Bond Indentures.

Reasons for Recommendation:

The Bond Indentures for CFD 1992-1, 2001-1 and 2005-1 require the Auditor-Controller to annually provide the Board of Supervisors with a list of Special Tax delinquencies. Attached are such lists as of July 24, 2006. Since this report, a number of parcels have paid their delinquent property taxes.

The Bond Indenture for CFD 1992-1 requires the County to foreclose on delinquent parcels after \$3,000 of delinquent tax excluding interest and penalties. There are currently two (2) parcels, that as of the date of this letter require the initiation of foreclosure proceedings. The Bond Indentures for CFD 2001-1 and 2005-1 require the County to foreclose on delinquent parcels after \$1,000 of delinquent tax. There are currently nine (9) parcels for CFD 2001-1 and one (1)

parcel for CFD 2005-1 that as of the date of this letter require the initiation of foreclosure proceedings. Attached are the Resolutions authorizing the judicial foreclosure of these delinquent special assessment taxes. The County is currently under contract with Calfee & Konwinski as counsel to foreclosure on liens of unpaid special taxes. Upon approval of the attached Resolutions, these matters of foreclosure will be referred to counsel to begin foreclosure proceedings.

Fiscal Impact:

No impact. Adequate funds are budgeted in the CFDs and foreclosure costs should be reimbursed from foreclosure proceeds.
