#### **Recommendation:**

Your Board is requested to authorize the Sheriff sign the Equipment and Operation Contract between the State of California, Department of Boating and Waterways, and the El Dorado County Sheriff's Office in the amount of \$60,000 for the replacement of a patrol boat and trailer.

#### Reason for Recommendation:

The State of California Department of Boating and Waterways provides the Sheriff with patrol boats for an intervention program on the County's lakes and waterways. One of the State owned Alumaweld boats utilized on Lake Tahoe and Fallen Leaf Lake is in need of replacement. The State has approved the Sheriff's request for funding in the amount of \$60,000 to replace the boat and trailer.

The Sheriff recognizes County Counsel's concern that a "Contract Administrator" be named as that is the standard language for a County contract. This contract however, is the State of California's standard Equipment and Operation Contract and the State is not willing to add or delete language to meet our needs. We are therefore requesting that the Board acknowledge that Sheriff Jeff Neves will act as the Contract Administrator for all purposes related to this contract.

### Fiscal Impact:

None. The State of California Department of Boating and Waterways is fully funding this purchase and there is no County match required.

#### **Action to be taken Following Approval:**

The Sheriff will sign the Equipment and Operations Contract. The Sheriff will provide Purchasing with the specifications for a request for formal bid.
