#### Subject: Perpetual Software Licensing Agreement with ComputerWorks

**RECOMMENDATIONS:** The Mental Health Department is advising the Board of a current perpetual software licensing agreement with ComputerWorks for on-going maintenance fees and recommending the Board:

- 1. Approve continuation of the perpetual software licensing agreement (the agreement automatically renews every November 9<sup>th</sup>); and
- 2. Authorize the Purchasing Agent to encumber funds for these licenses for the period of November 9, 2006 through November 8, 2007.

Any future changes to terms and conditions of this agreement will be brought to the Board for approval.

Funding Source: Medi-Cal and Realignment

**REASONS FOR RECOMMENDATIONS:** The Mental Health Department manages an agreement for medical software and the on-going maintenance and support for those licenses. This software product is used as the Department's scheduling and electronic medical records system. The Department, as part of the California Regional Mental Health System Coalition (JPA), is in the process of implementing a new medical software system, NetSmart's Avatar system, which will replace the Department's existing billing and electronic medical records systems; however the electronic medical records portion of the system will not be implemented until 2008. Once this portion of the system is in place, the Department will no longer need the medical software system provided by ComputerWorks.

We are bringing this matter before the Board so that you have the opportunity to be made aware of agreements that were approved by prior Boards.

Because of the value we receive from this product and the high quality of support we receive from the contracted vendor, Mental Health recommends the continuation of this perpetual agreement.

**FISCAL IMPACT:** The cost for this perpetual software licensing agreement for the period of November 9, 2006 through November 8, 2007 is \$8,190.00, including applicable taxes. The entire amount is due and will be paid in November 2006 against the FY 06/07 appropriation.

NET COUNTY COST: None

ACTION TO BE TAKEN FOLLOWING APPROVAL: Purchasing Agent shall encumber the funds for this agreement and Mental Health shall make payment upon receipt and approval of invoices. Any future changes to terms and conditions of this agreement will be brought to the Board for approval.
