### **Recommendations:**

The Department of Transportation recommends that the Board of Supervisors adopt and authorize the Chair to sign the attached Resolution:

- ratifying the results of the mailed ballot landowner election held on November 3, 2006 to consider a measure to establish a special tax for the Hawk View Road and Drainage Zone of Benefit #98613 within County Service Area #9; and
- 2. setting the annual special tax upon each parcel of real property within the boundaries of the zone in an amount not to exceeed \$381.00 commencing fiscal year 2007/2008, with annual adjustments tied to the Engineering News Report Construction Index.

### **Reasons for Recommendations:**

A condition of approval was placed on the Hawk View tentative subdivision map TM 00-1371 to form a county service area zone of benefit to provide a funding mechanism for the ongoing maintenance and eventual replacement of the roads and related drainage infrastructure within the subdivision. Your Board formed the Hawk View Road and Drainage Zone of Benefit #98613 on October 3, 2006 by Resolution 306-2006. The Engineer's Report prepared and submitted with the zone formation application resulted in a recommended first year annual special tax of \$381.00 per parcel.

California State law requires approval by two-thirds vote of qualified electors to establish a special tax; however the Elections Department has determined that there are no registered voters within the boundaries of the aforementioned zone. County Counsel opined that a landowner election would satisfy the voting requirement.

On October 3, 2006 your Board approved and adopted Resolution 305-2006 calling for a mailed ballot landowner election for Hawk View Road and Drainage Zone of Benefit #98613. The mailed ballot election was subsequently held on November 3, 2006. The ballots have been received and certified by the Director of Transportation. This measure has been approved.

### Fiscal Impact:

Any staff time associated with ratifying the election results or setting of the special tax will be paid from the first year's receipts. Staff time will be minimal.

### **Action to be Taken Following Approval:**

- 1. The Clerk of the Board will have the Resolution signed by the Chair, and will provide two certified copies of the Resolution to the Department of Transportation.
- 2. The Department of Transportation will provide the Auditor/Controller's office with a copy of the Resolution.

### OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

RATIFYING ELECTION RESULTS AND SETTING A SPECIAL TAX FOR THE HAWK VIEW ROAD AND DRAINAGE ZONE OF BENEFIT #98613 WITHIN COUNTY SERVICE AREA #9.

WHEREAS, the Board of Supervisors of the County of El Dorado has formed County Service Area #9 pursuant to Title 3, Division 2, Part 2, Chapter 2.2 of the California Government Code; and

WHEREAS, on October 3, 2006, this Board formed Hawk View Road and Drainage Zone of Benefit #98613 by Resolution 306-2006 for the purpose of providing road and drainage facility maintenance and improvement services; and

WHEREAS, California Government Code §25210.6a expressly authorizes a zone within a county service area to levy a special tax; and

WHEREAS, on October 3, 2006 this Board set a mailed ballot landowner election to consider a measure to establish a special tax for the purpose of providing road and drainage facility maintenance, repair and improvement services for Hawk View Road and Drainage Zone of Benefit #98613 by Resolution 305-2006; and

whereas, on November 3, 2006 the Department of Transportation properly submitted that measure to the landowners within the boundaries of the Hawk View Road and Drainage Zone of Benefit #98613; and

WHEREAS, the ballots have been received and counted, and the Director of Transportation hereby certifies that two-thirds of the qualified voters in the election have approved the measure;

NOW, THEREFORE, BE IT RESOLVED the Board of Supervisors determines as follows:

- 1. The results of the election for the measure to consider a special tax for the Hawk View Road and Drainage Zone of Benefit #98613 within County Service Area #9 are hereby ratified.
- 2. A first year annual special tax in an amount of \$381.00 shall be levied upon each parcel of real property within the boundaries of the Zone, and shall take effect commencing with fiscal year 2007/2008, with annual adjustments tied to the Engineering News Report Construction Index.

- 3. The services to be provided are extended County services as defined in California Government Code Section 25210.4a.
- 4. The special tax shall appear as a separate item on the tax bill of each affected parcel and shall be collected at the same time and manner as county ad valorem taxes are collected as set forth in the applicable provisions of the Revenue and Taxation Code, and shall be subject to the same penalties and the same procedure and sale in the case of delinquency as provided for such taxes. All laws applicable to the levy, collection and enforcement of county property taxes shall be applicable to each tax.
