Recommendations:

The Department of Transportation recommends the Board of Supervisors:

- Approve the Irrevocable Offers of Dedication for road right of way, including the underlying fee thereto for current and future public purposes, various public service easements, a slope easement and a temporary construction easement, affecting Lots 1, 2, 3, 6, 10, 11, 12, 13, 14, 23, 47 and 48 of the Large Lot Final map entitled "West Valley Village", recorded in Book J of Maps at Page 43, and Parcel A of Parcel Map #46/146.
- Authorize the Chairman to sign the Resolutions accepting, or acknowledging, but rejecting said offers, at this time. Said offers are necessary in order to satisfy a condition of approval of Tentative Map #TM99-1359, West Valley Village.

Reasons for Recommendation(s):

The Department of Transportation recommends that the Board approve the Irrevocable Offers of Dedication for road right of way, including the underlying fee thereto for current and future public purposes, public service easements, a slope easement and a temporary construction easement affecting all or a portion of said parcels, from the following property owners:

- MW Housing Partners III; West Valley Village, Lots 2, 10, 14 and 23
- West Valley LLC; West Valley Village, Lots 1, 3, 6, 11 and 12
- Centex Homes; West Valley Village, Lots 13, 47, and 48
- John Tsakopoulos Revocable Trust 2005, Dated June 7, 2005; PM#46/146, Parcel A

The Department also recommends that the Board authorize the Chairman to sign the Resolutions: accepting said road right of way, including the underlying fee (for current public purposes) on Lots 1, 2, 10, 11, 12, 13, 14, 23, 47, 48 and PM#46/146, Parcel A; acknowledging, but rejecting said road right of way, including the underlying fee, on Lots 3 and 6; acknowledging, but rejecting said road right of way, including the underlying fee, (for future public purposes, which is necessary for the future widening of Latrobe Road) on Lots 1, 2, 10, 11, 12, 13, 14, 23, 47, and 48; acknowledging, but rejecting said public service easements on Lots 1, 2, 10, 11, 12, 13, 14, 23, 47, and 48; accepting said slope easement and a temporary construction easement on PM#46/146, Parcel A.
