<u>Title</u>: Affordable Housing Agreement (Developer's Agreement) and Affordable Housing and Buyer's Occupancy and Resale Restriction Agreement (Buyer's Agreement).

Recommendations:

Human Services, Community Services Division, recommends that the Board:

- 1. Approve the implementation and use of an Affordable Housing Agreement (Developer's Agreement) and an Affordable Housing and Buyer's Occupancy and Resale Restriction Agreement (Buyer's Agreement) for use in developing affordable housing projects and preserving affordable housing units. Initially, the Agreements will be utilized to meet requirements set forth by the Planning Commission for the Lesarra Attached Homes residential condominium project. Both Agreements will be used as standard format to develop future affordable housing projects and preserve affordable housing units.
- Authorize the Director of Human Services to execute the Developer's and Buyer's Agreements on behalf of the County for the Lesarra Attached Homes residential condominium project and to execute said Agreements for any future affordable housing projects contingent upon approval by County Counsel and Risk Management of specific Agreements for each project.

Reasons for Recommendations:

Pacific West Company, dba Lesarra Attached Homes, Limited Partnership is developing a 160-unit residential condominium project which will include twelve (12) affordable housing units available to moderate income households. In order for the project to proceed, the Developer's Agreement must be executed between Lesarra Attached Homes, LP and the County. The Buyer's Agreement, which will be executed when individual units are sold, guarantees that the units remain available to moderate income households for no less than twenty (20) years. County Counsel and Risk Management have approved both Agreements. Copies of the Agreements are on file with the Board Clerk. Agreements for future projects will contain the same basic provisions, but may vary due to project specific requirements, which will be approved by County Counsel and Risk Management prior to execution.

Action to be Taken Following Approval:

Director of Human Services will execute Agreements for the Lesarra Attached Homes, LP condominium project. The Affordable Housing Agreement and the Affordable Housing and Buyer's Occupancy and Resale Restriction Agreement will be utilized for future affordable housing projects.
