## AGREEMENT FOR SERVICES # AGMT 04-754 Amendment I

THIS AMENDMENT I to that Agreement for Services # AGMT 04-754 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and David Ford Consulting Engineers, Inc., a corporation duly qualified to conduct business in the State of California, whose mailing address is P.O. Box 188529, Sacramento, California 95818, and whose principal place of business is 2015 J Street, Suite 200, Sacramento, California 95814, (hereinafter referred to as "Consultant");

### RECITALS

WHEREAS, Consultant has been engaged by County to provide as-needed hydrologic and hydraulic engineering services for the Department of Transportation pursuant to Agreement for Services # AGMT 04-754, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto desire to amend Agreement for Services # AGMT 04-754 to extend the expiration date of January 25, 2006 for one (1) additional one (1) year term amending ARTICLE II Term; and

WHEREAS, the parties hereto desire to amend Agreement for Services # AGMT 04-754 to include a revised fee schedule for the extended term of the Agreement, amending ARTICLE III Compensation for Services;

NOW, THEREFORE, County and Consultant mutually agree to amend the terms of the Agreement in this Amendment I to Agreement for Services # AGMT 04-754, to read as follows:

#### **ARTICLE II**

**Term:** The Agreement shall become effective when fully executed by the parties hereto and shall expire January 25, 2007.

### **ARTICLE III**

Compensation for Services: For services provided herein, including all deliverables required under the Task Orders described in Article I, Scope of Services, County agrees to pay Consultant monthly in arrears. Payment shall be made within thirty (30) days following County receipt and approval of itemized invoice(s) and progress reports detailing services rendered. For the purposes hereof, for the period commencing with the effective date of this Agreement and continuing through January 25, 2006, the billing rates for services performed shall be in accordance with Exhibit A, marked "Fee Schedule," incorporated herein and made by reference a part hereof. For the remaining term of the Agreement, the billing rates for services rendered shall be in accordance with Exhibit C, marked "Extended Fee Schedule," incorporated herein and made by reference a part hereof.

For the entire term of the Agreement, as amended, mileage expenses, if applicable, shall be paid in accordance with County's Travel Policy (No. D-1), Section 5b, attached hereto as Exhibit B, marked "Board of Supervisors Policy," incorporated herein and made by reference a part hereof.

The total amount of this Agreement shall not exceed \$35,000, inclusive of all expenses.

Except as herein amended, all other parts and sections of Agreement for Services # AGMT 04-754 shall remain unchanged and in full force and effect.
