PURPOSE OF FRIENDS REINVIGORATION

For more than ten years the "Friends" have been the catalyst for the creation, design, fund raising, and implementation of the Veteran's Memorial. After the dedication we breathed a big sigh of relief and started thinking about the rest of our lives. But events since Veteran's Day have indicated that our job is just beginning.

The monument has become a symbol that transcends its physical parameters. Families have scattered ashes of loved veterans there and many a tear has struck the pavement. As veterans we believe that we understand the true meaning of the memorial far better than political interests, and we have become concerned about the philosophy of political appointees who must accommodate both veterans and their bosses.

The nation's memorials are generally co-managed by government and private groups similar to the Friends and such an arrangement has worked very well for the Vietnam Memorial and others.

Accordingly the Friends is in the process of formal reconstitution and reinvigoration.

We intend to protect and enhance the concept of exclusive honor to those that served and to recognize such service consistent with the principle of the equal treatment provisions of our constitution that so many have died to defend. We will not allow the content or use of the Memorial to evolve to any other purpose, and we will work to make the Monument realize its full potential for the citizens of El Dorado County and all of those who served throughout the country.
