Dear Board Members:

#### **RECOMMENDATION:**

General Services Department recommending the Board approve and authorize the Chairman to sign a budget transfer to appropriate \$880,240.00 in revenues to the Placerville Airport Capital Improvement budget pursuant to the Memorandum of Understanding with New Faze Development.

### **REASON FOR RECOMMENDATION:**

On January 9, 2007 (Item 30) the Board approved a Memorandum of Understanding (MOU) with New Faze Development in the amount of \$880,240.00 to assist in removing obstructions at the east end of the Placerville Airport runway and provide the initial phase of development for a new hangar development area to be located on the northeast end of the airport property; authorized the Auditor-Controller to establish an appropriate account for the deposit of developer funds; and directed General Services to return to the Board on January 23, 2007 with the budget transfer to appropriate said funding. On January 23, 2007 this matter was continued to the January 30, 2007 meeting to allow sufficient time to establish the appropriate fund and prepare the budget transfer.

General Services recommends the Board approve the budget transfer to appropriate the funds from New Faze Development.

#### **FISCAL IMPACT:**

Capital project expenses for the associated activity are offset by developer funds. No change in County Cost.
