Dcar Ms. Chairperson:

I am writing to express my fervent concerns regarding the future of our El Dorado County Animal Services Shelter. As a dedicated member of this community and active volunteer for PAWED (People for Animal Welfare in El Dorado County), I feel it is our duty to insure the structural support necessary to meet this county's growing needs for responsible and effective companion animal, livestock, and wildlife management.

After several years of active participation with animal adoptions, I have observed the dedication and commitment from our county employees in an environment that is continuously suffering. Waves of urgent demands on their services erupt with minimal time for facility adjustment. Let us recall the efforts spent to secure contributions from non-county facilities during the recent livestock and canine confiscation cases. Response to such crises requires immediate resources on hand to maintain public safety AND safety to your employees. Crowded conditions contribute to employee stress, and escalate fear, arousal, and aggression in our confined animals.

During the past years, the current facility has suffered from lack structural improvement and expansions. It is obvious that it has fallen behind with current standards of county operations. This deferment of cost must be acknowledged from your Board. The plans on a new facility deserve this additional real savings to avoid creating such profound gaps in the immediate future. Do not waste our tax money on a facility that will be 'partially-functional' at completion. Not only would it be a disservice to your employees, it would guarantee need for further expenditures in the future. This is poor management and poor leadership.

The reality of overseeing the safety, welfare, and legal aspects of animal care in any community is a dangerous and emotional task. The population growth will continue to stretch our resources and public servants in an exponential manner. This compounds public confrontation and scrutiny. Our team deserves and requires an environment that fosters care as well as professionalism to public citizens. The new shelter will represent not only our commitment to compassion, but also responsibility to the law.

I ask that you understand that this project must protect and serve the entire Western slope for the next several decades. Let us do it right. The future belongs to those who are prepared.
