The contract bid documents indicated that 592,500 square feet of LLDPE 60 mil textured liner and 592,500 square feet of geocomposite would be required for this project. It has been determined that the project will require a total of 622,775 square feet (in place) of LLDPE 60 mil textured liner and 615,775 square feet (in place) of geocomposite due to additional use in overlapping, slopes and anchor trenches.

Bid Schedule, Bid Line Item #1: Shall be amended to a quantity of 622,775 square feet at \$.50 per square foot for material and installation of LLDPE 60 mil textured liner. For a total cost NOT TO EXCEED \$311,387.50.

<u>Bid Schedule, Bid Line Item #3:</u> Shall be amended to a quantity of 619,175 square feet at \$.515 per square foot for material and installation of geocomposite. For a total cost NOT TO EXCEED \$318,875.12.
