I strongly support the approval and installation of a day-use ball field at Light of the Hills Lutheran Church in Cameron Park. Please support our children in this community by voting in favor of the church's planned ball field at your upcoming December 11 Board of Supervisor's meeting.


As a past coach and Board member of the Foothill Girl's Softball League based in Shingle Springs, I can attest personally to the dire need in our county for softball fields. It is my understanding that soccer leagues are facing a similar dilemma. While local schools charge a fee to the FGSL for the use of their fields, it is the intent of Light of the Hills Lutheran to not charge a fee for the use of their field, if approved.

As former President of the Church Council at Light of the Hills, I can attest that the church has never intended to build a field with lights or a sound system. Although we never intended to have lights or a sound system, we made this commitment to the Cameron Estates CSD on several occasions that any field use would be daytime hours only, and would be fully controlled by the church office.

I understand that the County staff report indicates that independent consultants and County staff have studied potential increases of both noise and traffic, and no additional impact is expected from a new field on the church property. It should be further noted that the potential field in question, while intended to be both a soccer and a softball field, can not be used for both purposes at the same time due to its limited size.

As a relatively close property owner I share the close resident's concern re the public use of the field, lights, etc in a neighborhood. On the other hand, I realize that fields are generally in residential areas. I would not be entirely opposed to the development of that property if it's use were limited to daylight hours (no lights). The fact is that this is not a philanthropic venture...rather it's a business venture and the community WILL pay for it's use...we should not allow the LOFHs church to profit from something that will not be good for the local residents in Cameron Estates...even if the rest of the community that doesn't live close (and doesn't care if it's a nuisance to the adjacent owners) don't care.
