Our congregation has worked hard to be a helpful member of the community, by making our current building open for meetings and activities, including concerts, 12 step groups, recitals, meetings for several CSDs, and as an outlet for the El Dorado County Food Bank. We believe that the ball field is something our community needs. It is clear to those who live in this part of El Dorado County that there is a shortage of ball fields available for children and youth to use.

The ball field location across from Burke Junction and the Safeway Shopping area is an ideal, central location for the children of communities from El Dorado Hills to Placerville. Ample parking for the ball field is already available in the church parking lot.
