Dear Supervisors,

There have been a couple of inquiries regarding # 49 on tomorrow's BOS agenda. Item # 49 is a hearing to consider the appeal of conditions imposed by EMD upon a parcel split of 2.92 acres to create two parcels of 1.0 acre and 1.92 acres. The legislative text states that as a condition of approval EMD is requiring the abandonment of the wells currently located on the property because the wells do not meet current construction standards, and because the wells could potentially contaminate the public water system. The legislative text also refers to a letter prepared by EMD to the applicant, which was not included in the attachments.

I am attaching the letter referenced in the legislative text for your review. I believe this letter will help to clear up the confusion surrounding this issue. In brief, EMD is requiring the abandonment of the existing wells in order to comply with the Section 5.2 of the General Plan. The proposed parcel split will create parcels less than 5 acres that are served by both well water and onsite septic systems.

Dear Ms. Singh:

A Zoning Administrator Hearing was held today regarding the above-referenced project. Environmental Health staff stated for the public record that for this project both parcels shall connect to the public water system that is available to the project, and that both existing wells on the property shall be properly destroyed under permit through this office.

El Dorado County General Plan Policies 5.3.1.2. and 5.2.3.5 do not allow for the creation of parcels less than 5 acres unless the properties are served by public water. Wells not meeting the current construction standards have the potential of causing groundwater degradation, and smaller lots with septic systems and wells are known to be a threat to groundwater. Also, the use of wells and public water servicing the same structure(s) has the potential to contaminate the public drinking water supply.
