# A RESOLUTION REQUESTING APPROVAL BY THE COUNTY OF EL DORADO OF PROPOSED RESOLUTION OF INTENTION AND BOUNDARY MAP UNDER SECTION 10104 OF THE STREETS AND HIGHWAYS CODE OF CALIFORNIA

## CAMERON PARK AIRPORT DISTRICT Assessment District No. 2008-1

**RESOLVED** by the Board of Directors (the "Board of Directors") of the Cameron Park Airport District (the "District"), County of El Dorado, State of California, that

WHEREAS, the District is an airport district, duly organized and operating under the laws of the State of California;

WHEREAS, it is the intention of the Board of Directors to begin special assessment proceedings under the Municipal Improvement Act of 1913 (Division 12 of the California Streets and Highways Code) (the "Act") for the making of road improvements consisting generally of the reconstruction and resurfacing of roads and the construction of storm drainage improvements within the District, by the adoption of a Resolution of Intention to Make Acquisitions and Improvements (the "Resolution of Intention") for the District's proposed Assessment District No. 2008-1 (Road Project) (the "Assessment District"), and to assess the costs thereof and the expenses incidental thereto upon the Assessment District benefited thereby, the exterior boundaries of which are shown on the Map of Proposed Boundaries of the Assessment District (the "Boundary Map"), a copy of which is on file in the office of the Secretary of the District;

**WHEREAS**, the land to be assessed lies within the unincorporated territory of the County of El Dorado (the "County");

WHEREAS, the proceedings are being initiated by the Board of Directors, being a legislative body other than that of a city or a county and, therefore, Section 10104 of the Act requires that the form of the Resolution of Intention and the form of the Boundary Map for the Assessment District be approved by the Board of Supervisors of the County, as the legislative body of the County;

**WHEREAS**, the public health, safety, interest, convenience and necessity will be served by the making of the acquisitions and improvements and the levying of the assessments;

#### NOW, THEREFORE, IT IS ORDERED, as follows:

- 1. Request is made that the proposed Resolution of Intention to be adopted by the Board of Directors in the proceedings and the Boundary Map for the Assessment District be approved, by resolution, by the Board of Supervisors of the County.
- 2. The Secretary of the District is directed to file with the Clerk of the Board of Supervisors of the County a certified copy of this Resolution, together with copies of the proposed Resolution of Intention and the Boundary Map for the Assessment District.
