## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

## RESOLUTION AUTHORIZING COUNTY SERVICE AREA NO. 3 SOUTH SHORE SNOW ZONE OF BENEFIT NO. 98501 CONTRIBUTION TO TAHOE RESOURCE CONSERVATION DISTRICT ROAD TO BLUE PROJECT

**WHEREAS**, the Board of Supervisors of the County of El Dorado has formed County Service Area No 3 pursuant to Title 3, Division 2, Part 2, Chapter 2.5 of the California Government Code; and

**WHEREAS,** this Board formed Zone No. 2 by Resolution 348-86 to provide snow removal services in the unincorporated area of CSA No. 3; and

**WHEREAS,** this Board formed the South Shore Snow Zone No. 98501 by Resolution 249-93 on August 9, 1993 for the purpose of providing snow removal services to the unincorporated area of the South Shore of the Tahoe Basin; and

**WHEREAS,** funding for zone activities is through a service charge/assessment in the amount of twenty dollars (\$20.00) for each improved parcel of land, which has not kept pace with the cost of providing services; and

**WHEREAS**, the Tahoe Resource Conservation District (RCD) has partnered with the County, the City of South Lake Tahoe, and Placer County to collaborate financially through a project called Road to Blue to engage stakeholders to seek and gauge support of potential long-term funding strategies for implementation of storm water, snow removal, and transportation programs in Lake Tahoe; and

**WHEREAS,** efforts of the Tahoe RCD and Road to Blue provide an opportunity for the County to leverage public outreach activities to explore long term strategies to address funding deficiencies for South Shore Snow Zone; and

WHEREAS, the County has identified funding from the South Shore Snow Zone for a matching one-time contribution in the amount of \$15,000 to be combined with contributions from the City of South Lake Tahoe and Placer County to support the Tahoe RCD's efforts to survey and determine the public's level of commitment in supporting different potential funding initiatives for snow removal equipment replacement within the South Shore Snow Zone as part of the Road to Blue program; and

WHEREAS, the Board of Supervisors has determined that a public benefit is derived from the financial contribution to assist Tahoe RCD in surveying and determining the public's level of commitment in supporting different potential funding initiatives for snow removal equipment replacement within the South Shore Snow Zone; and

**WHEREAS,** the funding provided herein will provide a valuable public purpose of supporting Tahoe RCD's effort to address funding deficiencies for the South Shore Snow Zone; and

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of El Dorado approves and authorizes the Auditor-Controller to disperse funding in the amount of \$15,000 from the South Shore Snow Zone account to the Tahoe RCD for the purpose of supporting Tahoe RCD's efforts to survey and
