MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Mosquito Volunteer Fire Association, a California corporation whose principal place of business is 9009 Orval Beckett Court, Placerville, CA 95667 (hereinafter referred to as "MVFA");

WITNESSETH

WHEREAS, County has appropriated a contribution to MVFA in the amount of \$10,000 to be used for the payment of fees owed by MVFA to the California Division of Dam Safety for the Finnon Lake Reservoir; and

WHEREAS, County and MVFA have agreed that the MVFA make payment for the abovereferenced fees.

NOW THEREFORE, the parties do hereby agree as follows:

Within 30 days after execution of this Memorandum of Understanding, County will advance funds to the MFVA in the amount of \$10,000 to be used solely for the purpose of payment of fees owed by the MVFA to the California Division of Dam Safety for the Finnon Lake Reservoir. Upon payment of the fees, the MVFA shall provide County with proof of payment of fees to the California Division of Dam Safety and shall return any unused funds. If the advanced funds have not been used for the purpose stated herein within one (1) year of execution of this MOU, all funds shall be returned to County.

This document and the documents referred to herein or exhibits hereto are the entire Agreement between the parties and they incorporate or supersede all prior written or oral Agreements or understandings.
