Behavioral Health Court Goals

- Reduce jail recidivism by use of comprehensive wrap-around services
- Bring stability, sobriety, safety to mentally ill individuals in Criminal Justice System
- Increase productivity for participants in education and work environments
- Promote public safety, ensure security and well-being of entire community

Behavioral Health Court

- Looks at nexus between mental illness and behavior that led to arrest
- Utilizes team approach and supports clients better served by treatment than incarceration
- Provides intensive program designed to evaluate, treat and monitor participants
- Provides coordinated, comprehensive mental health and substance abuse treatment
- Enables individual to become participating, productive member of our community
- El Dorado County Behavioral Health Court is part of a successful nationwide trend

Behavioral Health Court - Recommendations

- Provision of appropriate, professionally staffed housing, based on best needs of the individual.
 Continuation of cross-training of BHC team; utilization of outside professionals and consultants.
 Addition of Dual Diagnosis Professional to Behavioral Health Court Team.
- Enhanced collaboration between departments, ancillary service providers, and family members when appropriate.
- Ensure wrap around services are in place to assist the individual with mental illness to become a productive member of our community.

Psychiatric Health Facility (PHF)

- The PHF is a 15 bed licensed residential facility
- Average occupancy of 8.9 patients per day for 2007
- Average length of stay is six (6) days
- The California Department of Mental Health in reviewed the PHF in March, 2007. The PHF was granted full approval and judged to be in substantial compliance with state regulations
