MEMORANDUM OF UNDERSTANDING # 453-M0811 AMENDMENT I

This Amendment I to that Memorandum of Understanding #453-M0811 made and entered into by and between the County of El Dorado County Department of Human Services-Community Services Division (hereinafter referred to as "DHS" or "County") and United Outreach of El Dorado County, a California 501(c)(3) non-profit organization, duly qualified to conduct business in the State of California, whose principal place of business is 2560 Clarksville Road, Rescue, CA 95672 and whose mailing address is Post Office Box 1675, Diamond Springs, CA 95619 (hereinafter referred to as "Contractor").

WITNESSETH

WHEREAS, on August 28, 2007 the County Board of Supervisors approved General Fund Contingency for operating costs for Grace Place, an emergency shelter for homeless, and Memorandum of Understanding #453-M0811 between DHS and Contractor in a maximum amount of \$42,000 was executed by the Purchasing Agent on August 29, 2007; and

WHEREAS, the Mental Health Department, as part of their outreach and engagement services to the homeless population, has agreed to provide Proposition 63 Mental Health Services Act (MHSA) revenue in the amount of \$21,000 to DHS to supplement previously allocated General Fund Contingency to support continued operating costs for Grace Place during the 2007/08 Fiscal Year; and

WHEREAS, the parties hereto have mutually agreed to amend ARTICLE III - Compensation.

NOW, THEREFORE, the parties do hereby agree that Memorandum of Understanding #453-M0811 shall be amended a first time as follows:

ARTICLE III

Compensation: For services provided herein, DHS agrees to pay Contractor monthly in arrears and within thirty (30) days receipt and approval of itemized invoice(s) identifying services rendered. For the purposes herein, payment shall be in accordance with Revised Exhibit "A", marked "Budget", incorporated herein and made part by reference hereof. Operating costs reimbursed by DHS will represent actual costs incurred for the provision of services detailed in ARTICLE I. The total amount of this Memorandum of Understanding shall not exceed \$63,000.00.

Except as herein amended, all other parts and sections of that Agreement #453-M0811 shall remain unchanged and in full force and effect.
