OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

RESOLUTION AUTHORIZING GREEN PROCUREMENT

WHEREAS, the County of El Dorado is committed to making efficient use of natural resources by practicing waste reduction and recycled content product procurement in all aspects of its internal and external operations.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the County of El Dorado, to the extent possible and practical, the County will establish the following green procurement provisions.

- 1. Print documents and communications double-sided.
- 2. Use electronic mail and voice mail.
- 3. Reuse envelopes.
- 4. Buy and use paper with at least 30 percent post-consumer recycling content.
- 5. Purchase a recycled product instead of a non-recycled product whenever possible and request products made with the highest percentage of post-consumer material available.
- 6. Purchase reused diskettes.




