AGREEMENT Between Bureau of Land Management And El Dorado County

RELATING TO THE FUNDING OF A PRESERVE MANAGER POSITION FOR THE PINE HILL PRESERVE

AUTHORITY

THIS AGREEMENT is entered into as of the date of the last signature affixed hereto, by and between the COUNTY OF EL DORADO, a political subdivision of the State of California, (hereinafter "County"), and UNITED STATES DEPARTMENT OF INTERIOR acting by and through the Bureau of Land Management, Folsom field Office, (hereinafter "BLM"), pursuant to (Federal Land Policy Management Act, 1976: Section 307 (b) and (c)). This agreement supplements the Cooperative Management Agreement for the Pine Hill Preserve (Cooperative Management Agreement) signed by the County September 12, 2006 and signed by BLM July 7, 2006. This agreement implements an El Dorado County Board of Supervisors decision of March 25, 2008.

PURPOSE

THE PURPOSE OF THIS AGREEMENT is to provide funding for a Preserve Manager for the Pine Hill Preserve to meet the goals and objectives of the Cooperative Management Agreement, as that document may be amended from time to time.

IT IS HEREBY AGREED AS FOLLOWS:

I. The BLM shall:

- A. Provide a full time Preserve Manager for the Pine Hill Preserve working out of the Folsom Field Office.
- B. Supervise and direct the employee's work.
- C. Provide necessary vehicle, equipment and office space for employee to conduct the job.
- D. Use all funds provided by El Dorado County to fund the Preserve Manager position established by this agreement.
- E. Providing an annual written report to the County documenting the activities completed during the previous year, expenditures, and other accomplishments.

II. The County shall:

A. By July 31 of each year during the term of this agreement, transfer to the BLM twenty five thousand dollars (\$25,000) for use by BLM in partially funding the annual costs of the Preserve Manager position for the Pine Hill Preserve. Within 30 days of the effective date of this Agreement, County shall make a prorated payment for the balance of the 2007-2008 fiscal year. A check may be made payable to Bureau of Land Management and sent via first class mail to:

III. AMENDMENTS

Should additional lands be incorporated into the Preserve system, the dollar amount cited in paragraph II.A may be adjusted as necessary by mutual agreement of both parties.

IV. TERM OF THE AGREEMENT

This cooperative Agreement will become effective on the date of the latest signature thereto, and shall expire on June 30, 2012. Although this agreement represents the parties' intention to fund the Preserve manager's for multiple years, nothing in the agreement shall obligate either party to execute a new agreement for the funding of this position when this agreement expires after 5 years. If there is mutual agreement to continue this funding mechanism for the Preserve Manager's position beyond the years covered in this agreement, a new written agreement between the parties will be executed.

V. AUTHORIZED OFFICERS

BLM Authorized Officer shall be:

The County Authorized Officer shall be:

Larry Appel, Deputy Director of Planning Services El Dorado County 330 Fair Lane Placerville, CA 95667

VI. AMENDMENTS

AMENDEMENTS TO THIS AGREEMENT may be proposed by either party and shall become effective upon being reduced to a written instrument executed by both parties.

VII. TERMINATION

Either party hereunder may terminate this agreement for any reason or no reason upon thirty (30) days written notice: provided, however, that the terminating party has performed all of its obligations required hereunder. Either party may terminate his contract upon five (5) days written notice if the other party, for any reason whatsoever fails, refuses or is unable to perform its obligations under this agreement. If the agreement is terminated before the end of the term of the agreement, i.e., before June 30, 2012, payment from the County to BLM will be returned to the County on a prorated basis, based on that portion of the year that the agreement was in effect before termination.

VIII. COUNTY ADMINSTRATOR

The administrator of this contract for the County shall be Larry Appel, Deputy Director of Planning Services, or his designee or successor.
