

RESOLUTION NO.

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

Whereas, El Dorado County's Senior Day Care Program has operated successfully on a fee-for-service basis since its establishment at the Placerville site in 1989, and

Whereas, the demand for Senior Day Care Program services continues to increase and a second program site in El Dorado Hills will commence operations in 2008, and

Whereas, a need exists to expand the hours of operation, currently 8:00 am to 5:00 pm, to 7:30 am to 5:30 pm in order to offer improved program access to working individuals who provide care for a loved one, and

Whereas, said expansion of hours necessitates an adjustment to the rate structure to offset staffing costs for the expanded hours of operation, and

Whereas, the fee schedule for the Senior Day Care Program is established by action of this Board, with daily fees for regular attendees set on a sliding scale based on frequency of attendance, currently and through June 30, 2008, ranging from base rates of \$37 to \$44 for private pay participants, with an Agency Reimbursement Rate of \$45, a short-term enrollment rate of \$44 and an Application Processing Fee of \$44, with provision for an annual increase of \$1.00 in each category on the first day of each fiscal year, and

Whereas, it is necessary to impose higher fees of \$50 for Application Processing and \$52 per basic program hour day for planned short-term (less than 30 days) enrollment to accommodate initial intake and care planning costs.

Now Therefore Be it Resolved, by the El Dorado County Board of Supervisors that the Senior Day Care Program is hereby authorized to expand hours of operation at each of its locations from 8:00 am through 5:00 pm to 7:30 am through 5:30 pm, with Basic Program Hours set at 8:30 am to 4:30 pm, effective July 1, 2008, and

Be it Further Resolved, by the El Dorado County Board of Supervisors that the Senior Day Care Program fee schedule is hereby amended to include an additional daily charge of \$10 for early arrival or late departure (before 8:30 am or after 4:30 pm) and \$15 for both early arrival and late departure (before 8:30 am and after 4:30 pm) to the Basic Program Hours daily rates ranging, based on frequency of attendance, from \$38 to \$45 for regular attendees, \$46 for agencies and \$52 for short-term enrollees; and to increase the daily Short-Term Enrollment Fee to \$52, the Application Processing Fee to \$50 and the charge for delivery or pickup outside of regularly scheduled hours to \$2.00 per minute, all changes to take effect July 1, 2008, with the continued option to raise the daily Basic Program Hours attendance fee in each category by \$1.00 annually on July 1st thereafter if necessary to meet increased program operating costs.
