EL DORADO COUNTY PUBLIC COMMUNICATIONS SERVICES INMATE PHONE MANAGEMENT AGREEMENT

Amendment No. 3

This Immate Phone Management Agreement Amendment No. 3 is made by and between Public Communications Services, Inc. ("PCS") and the El Dorado County Sheriff and the El Dorado County Probation Department (collectively, "Client"), as of this _/ * date January, 2005 with reference to the following:

WHEREAS: Client has, in concert with the El Dorado County Probation Department, requested installation of pay telephone services to the Juvenile Hall facilities located in Placerville and Lake Tahoe, and

WHEREAS: PCS subsequently installed such systems in Placerville in December 2003 and Lake Tahoe in September 2004 and agreed with Client and Probation that approximately six months following final installation that the services to the Juvenile Hall facilities would be reviewed as to rates, commissions and related issues and that review has now been concluded,

THEREFORE: Client and PCS amend Addendum B of their Agreement as follows effective upon execution:

Addendum B, Section "c" is amended to read:

"Commissions: Commissions to be paid to El Dorado County Probation Department will be calculated on gross revenue. Gross revenue is defined as all gross revenues received for local, IntraLata, InterLata and Interstate charges from all revenue streams. Commissions will be paid monthly at a rate of forty-five (45%) of all revenues received from all phones and from all sources. Additionally PCS shall make this commission rate retro-active to January 2004, shall conduct an audit of all phones and revenues and shall, if appropriate, pay to El Dorado County Probation Department any arrears commissions that would have been earned under this revised aggregated, rather than per phone, commission base and rate."

Addendum B, Section "d" is amended to delete the word "billable".

Addendum B, Section "e" is amended to read:

"Rates and Tariffs: To ensure maximum value to ward/detainees and their families and to ensure equitable treatment for all persons incarcerated within El Dorado County the juvenile phone rates shall be based upon inmate phone rates, rather than the more expensive public phone rates, and be consistent by call type (collect, pre-paid collect and debit) with the rates charged to inmates in custody of the Sheriff. The present rates are included as Exhibit 1 to this Amendment."
