

## RESOLUTION NO. OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

## SOUTH TAHOE REFUSE CO., INC. AREA B SCHEDULE OF RATES

**WHEREAS,** County Ordinance section 8.42.150 provides that the Board of Supervisors shall set the rates to be charged by a franchisee at such times as the Board deems appropriate; and

WHEREAS, Section 22 of the First Amendment to the Solid Waste Services Agreement between the County of El Dorado and South Tahoe Refuse Co., Inc., provides for a four percent (4%) rate increase effective January 1, 2017 for South Tahoe Refuse Area B (formerly American River Disposal Service); and

WHEREAS, customers of South Tahoe Refuse Area B have requested bear-proof containers and the option for bear-proof containers will be provided to customers for an additional monthly charge of \$10.00 per rental; and

WHEREAS, pursuant to County Ordinance section 8.42.170, the franchisee has provided written notice to each ratepayer of the proposed adjustment in a form approved by the County of the time, date, and place of the public hearing to set rates and the notice was provided at least ten but no more than sixty days before the public hearing; and

WHEREAS, pursuant to County Ordinance section 8.42.170, notice of the time, place, and purpose of the public hearing has been published in a newspaper of general circulation printed and published in the County, once each week, for two consecutive weeks prior to such hearing; and

**WHEREAS**, a public hearing was held on December 13, 2016, for the purpose of adjusting solid waste collection rates within the franchise area of South Tahoe Refuse Area B; and

WHEREAS, the South Tahoe Refuse Area B solid waste collection rates shall have a four percent (4%) increase effective January 1, 2017.

**NOW, THEREFORE,** be it resolved that effective January 1, 2017, the following rates are adjusted upward four percent (4%) for the collection of solid waste within the South Tahoe Refuse Co., Inc., Area B franchise area:
