Dave - I believe this is the standard language from which we have always approved. Yes, this is a subtle discrepancy within their Agreement which affords some further thoughts. I have discussed this item with Penny Stewart with the conclusion of, the Grant Agreement provisions for Site Improvement Grants require the County to maintenance the improvements for 20 years which we comply with by resolution. However, we know that even after 20 years these same improvements, as constructed, will still require maintenance by the County, unless we can strike the perpetuity language. Let's discuss further, however, for now, I believe that we are covered under the requirements of the Grant and LA for maintenance of the improvements.

Steve,

I have the license agreement for Angora 3. It contains what is, in my view, an internal inconsistency so I wanted to run this by you to determine if it creates a problem. In the paragraph entitled "Term of the Agreement," the agreement states that "if erosion control project improvements are constructed on the Property within said period, the County shall have the right to enter on the Property for up to twenty (20) years from the date of completion of said improvements, for maintenance purposes as set forth herein." But in the paragraph entitled "Maintenance," the agreement appears to require that we maintain the improvements in perpetuity. How can we maintain the improvements in perpetuity if we only have the right to enter the property for the next twenty years? What are your thoughts on this? How have these provisions been interpreted in the past?
