FISCAL IMPACT/CHANGE TO NET COUNTY COST:

The current engineer's estimate for the construction phase of this project is estimated at \$585,000.00, which includes a bid of \$493,436.00, construction management and materials testing at \$42,219 and a contingency of \$49,345. There is no cost to the County General Fund associated with this agenda item.

REASON FOR RECOMMENDATION:

On August 19, 2008 your Board approved the Specifications and authorized the Transportation Department to advertise for construction bids.

On September 9, 2008, the Department received 6 bid proposals for the project as follows:

The engineer's construction bid estimate for this project is \$510,000.00. The low bid is \$493,436.00.

After reviewing the bid received from Teichert Construction, Inc., it has been determined the proposal is both responsive and responsible. Given that finding and their low bid, the Department recommends the contract be awarded to Teichert Construction, Inc.

ACTION TO BE TAKEN FOLLOWING BOARD APPROVAL:

- 1. The Department will forward the approved Construction Contract to Teichert Construction, Inc. for their signature.
- 2. Upon receipt of the Construction Contract from Teichert Construction, the Department will submit the final Contract Documents, including the required bonds and insurance, to County Counsel and Risk Management for their review and approval.
- 3. Upon approval by County Counsel and Risk Management, the Department will forward the Construction Contract, together with the required bonds and insurance, and the approved contract routing sheet to the Board Clerk for the Board Chairman's signature on the Construction Contract.
- 4. Upon receipt of the fully-executed Construction Contract, the Department will forward the approved Contract to Teichert Construction, Inc. and will issue a Notice to Proceed.
