

RESOLUTION NO. 287-2008

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, on October 7, 2008 the Board of Supervisors approved the proposed reorganization of the Public Health and Mental Health Departments; and

WHEREAS, as a result of the reorganization, the Department of Public Health and the Department of Mental Health will be merged to form the Department of Health Services; and

WHEREAS, as a result of this merger, the previous Department of Public Health and the Department of Mental Health will be eliminated; and

WHEREAS, as a result of the reorganization, the positions of 1.0 Director of Public Health and 1.0 Director of Mental Health will be eliminated; and

WHEREAS, in order to perform services in a more efficient manner as a result of the reorganization new positions of 1.0 Director of Health Services and 1.0 Chief Fiscal Officer, have been added; and

WHEREAS, in accordance with Section 202 of the El Dorado County Compensation Administration Resolution #227-84 applicable to represented employees, and Section 501 of the Salary and Benefits Resolution #323-2001 applicable to unrepresented employees, the Board of Supervisors shall by Resolution specify the number and classification of all authorized positions of each department of the County; and

WHEREAS, in accordance with Section 203 of the El Dorado County Compensation Administration Resolution #227-84 applicable to represented employees, and Section 601 of the Salary and Benefits Resolution #323-2001 applicable to unrepresented employees, the Board of Supervisors shall by Resolution establish the salary for all authorized positions within the County.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of El Dorado approve the new job specification, implement the designated bargaining unit and adopt the salary range for the Director of Health Services as listed below become effective pay period 22:

BE IT FUTHER RESOLVED that the Authorized Personnel Allocation Resolution #271-2008, as amended, is hereby amended to eliminate the prior departments of Public Health and Mental Health, and to establish the number and classification of authorized positions in the Department of Health Services as set forth below effective pay period 22.
