



**RESOLUTION NO.**  
**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**

**WHEREAS**, on September 13, 2011 the Board approved Agreement 303-S1110 with Municipal Code Consultants, Inc, for the purpose of updating and modernizing the county ordinance code and to provide for ongoing updates as ordinances are adopted or amended by the Board; and

**WHEREAS**, the update effort includes a change to provide that the amount of fees established by ordinance can be updated by resolution rather than by ordinance where allowed by law; and

**WHEREAS**, on November 17, 2014, the Board of Supervisors passed the updated code; and

**WHEREAS**, the updated code will become effective December 17, 2014, at which time certain ordinances will be repealed; and

**WHEREAS**, the ordinance provisions to be repealed include provisions identifying fee amounts for various permits; and

**WHEREAS**, to continue to collect the various fees that have been adopted once the ordinance provisions setting the amounts of those fees have been repealed, the Board must simultaneously set the fee amounts by resolution; and

**WHEREAS**, this resolution **will not establish any new fees or increase the amount of any existing fees**, but will only allow the county to continue to collect fees previously adopted by ordinance; and

**NOW, THEREFORE, BE IT RESOLVED** the Board of Supervisors hereby adopts the following fee amounts, **effective December 17, 2014**:

Section 5.32.030 Permit – Outdoor Music Festivals	\$500
Section 5.44.060 Permit – Emergency Alarm Systems	\$30
Section 5.44.090 Permit – Renewal of Emergency Alarm Systems	\$25 / Business \$10/ Residential
Section 5.44.100 Permit – Transferability of Emergency Alarm Systems	\$10
Section 5.48.050 Permit – Streams and Rivers Commercial Boating	\$25 / Appeal
Section 12.08.160 Permit – Encroachment Permit Fees	\$30 / Excavation or Obstruction
