*Forecasted impacts to the County's road network have not changed, and therefore the proposed CIP project list remains unchanged as presented in April 3


LEVEL OF SERVICE (LOS)

Question regarding validity of El Dorado County's calculation of existing LOS at 8/30/16 Measure E discussion

- Caltrans and El Dorado County both rely on industry accepted methodologies – 2010 HCM
- El Dorado County does use the PeMS data as approved by Caltrans (Caltrans uses a Count book with information that has not changed in more than 7 years)



OLD TIM Fee Program

• Allocates cost for Highway 50 projects in Zone 8 to Zone 8 Local TIM Fee Fund

New TIM Fee Program

 Allocates cost for Highway 50 projects to Highway 50 Fund

2. TIM FEE NEXUS STUDY – WEST VALLEY VIEW

Unforeseen potential consequence

Could lengthen repayment timeline to WVV for Silva Valley Interchange

> Thereby reducing the "value" of the Zone 8 Local Tim Fee set aside to reimburse WVV

2. TIM FEE NEXUS STUDY WEST VALLEY VIEW

Revision

Reallocate cost for two interchanges in Zone 8 back to Zone 8 TIM Fee Fund

No net fee increase or decrease with this change Keeps WVV on same projected reimbursement timeframe

2. TIM FEE NEXUS STUDY AMENDMENTS DIAMOND SPRINGS PARKWAY

Measure E - Policy TC-Xa 4 of Measure E states:

"County tax revenues shall not be used in any way to pay for building road capacity improvements to offset traffic impacts from new development projects."

If it is determined that Diamond Springs Parkway is not eligible to use MC&FP funding, staff recommends Diamond Springs Parkway Phase 1B funding be replaced with Tribal Funds and/or TIM Fee funds.

2. TIM FEE NEXUS STUDY AMENDMENTS 3 SCENARIOS – NO MC&FP FUNDS

Scenario 1 - Result: Same TIM Fees*

- TIM Fee Revenue (no change)
- Tribal Funds (\approx \$13M)

Scenario 2 - Result: Increase in TIM Fees*

• TIM Fee Revenue Increase

• Tribal Funds (≈ \$8M)

Scenario 3 - Result: Increase in TIM Fees*

- TIM Fee Revenue Increase
- Tribal Funds Removed

NEXT STEPS (CONTINUED)
