The County of El Dorado Planning Commission will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on February 9, 2017, at 8:30 a.m., to consider the following: Conditional Use Permit S15-0014/T-Mobile Keetak Street submitted by T-MOBILE (Agent: Karen Lienert) to allow the construction and operation of a wireless telecommunistruction and operation of a wireless telecommunication facility consisting of a 100-foot tall monopine tower with six panel antennas and six tower mounted amplifiers mounted at 96 feet, and a 200-square foot equipment shelter with air conditioning units surrounded by chain link fencing with green privacy slats, all within a 1,250 square foot lease area.
