OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

RESOLUTION APPROVING MOTOR VEHICLE REGISTRATION FEE PURSUANT TO SECTION 44223 OF THE CALIFORNIA HEALTH AND SAFETY CODE (AB2766SHER)

WHEREAS, the California Clean Air Act of 1988 (Chapter 1568) requires local air pollution control districts to reduce emissions from motor vehicles; and

WHEREAS, Section 44223, added to the Health and Safety Code by action of the California Legislature on September 30, 1990, (Chapter 90-1705) authorizes the El Dorado County Air Pollution Control District to impose a fee; and

WHEREAS, Section 9250.17, added to the California Motor Vehicle Code by action of the California Legislature on September 30, 1990, (Chapter 90-1705) authorizes the Department of Motor Vehicles to collect fees requested by the District Board; and

WHEREAS, the El Dorado County Air Pollution Control District has been declared a state nonattainment area for Ozone;

NOW, THEREFORE BE IT RESOLVED that the Air Pollution Control Board of the El Dorado County Air Pollution Control District hereby requests a fee of two dollars (\$2) be levied on all fee paying registered motor vehicles in El Dorado County, commencing on October 1, 1991, and requests the California Department of Motor Vehicles to collect and distribute said fees pursuant to Section 9250.17 of the California Vehicle Code.

BE IT FURTHER RESOLVED that the El Dorado County Air Pollution Control District intends to use the above fees to reduce air pollution from motor vehicles pursuant to the California Clean Air Act of 1988 (Chapter 1568) including carrying out related planning, monitoring, enforcement, and other technical activities.

RESOLUTION NO. 70-94

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, the California Clean Air Act of 1988 (Chapter 1568) requires local air pollution control districts to reduce emissions from motor vehicles; and

WHEREAS, Section 44223, added to the Health and Safety Code by action of the California Legislature on September 30, 1990, Chapter 90-1705) authorizes the El Dorado County Air Pollution Control District to impose a fee; and

WHEREAS, Section 44225, added to the Health and Safety Code by action of the California Legislature on September 30, 1990, (Chapter 90-1705) authorizes the El Dorado County Air Pollution Control District to increase the fee established under Section 44223 to up to four (\$4); and

WHEREAS, Section 9250.17, added to the California Motor Vehicle Code by action of the California Legislature on September 30, 1990, (Chapter 90-1705), authorizes the Department of Motor Vehicles to collect fees requested by the District Board; and

WHEREAS, the El Dorado County Air Pollution Control District has been declared a state nonattainment area for Ozone:

NOW, THEREFORE BE IT RESOLVED, that the Air Pollution Control Board of the El Dorado County Air Pollution Control District hereby requests a fee of four dollars (\$4) be levied on all fee paying registered motor vehicles in El Dorado County, commencing on October 1, 1994, and requests the California Department of Motor Vehicles to collect and distribute said fees pursuant to Section 9250.17 of the California Vehicle Code.

BE IT FURTHER RESOLVED, that the El Dorado County Air Pollution Control District intends to use the above fees to reduce air pollution from motor vehicles pursuant to the California Clean Air Act of 1988 (Chapter 1568) including carrying out related planning, monitoring enforcement, and other technical activities.

RESOLUTION NO. 079-2006

OF THE BOARD OF DIRECTORS OF THE EL DORADO COUNTY AIR QUALITY MANAGEMENT DISTRICT

RESOLUTION APPROVING MOTOR VEHICLE REGISTRATION FEE INCREASE PURSUANT TO SECTION 44223 OF THE CALIFORNIA HEALTH AND SAFETY CODE (AB 923 FIREBAUGH)

WHEREAS, the California Clean Air Act of 1988 (Chapter 1568) requires local air quality management districts to reduce emissions from motor vehicles; and

WHEREAS, Section 44223, added to the Health and Safety Code, by action of the California Legislature on September 30, 1990, (Chapter 90-1705) authorizes the El Dorado Air Quality Management District to impose a fee; and

WHEREAS, Section 44225, of the Health and Safety Code, amended by action of the California Legislature on September 23, 2004, authorizes the El Dorado Air Quality Management District to increase the fee established under Section 44223 to up to six dollars (\$6); and

WHEREAS, Section 9250.17, added to the California Motor Vehicle Code by action of the California Legislature on September 30, 1990 (Chapter 90-1705) authorizes the Department of Motor Vehicles to collect fees requested by the District Board; and

WHEREAS, the El Dorado County Air Quality Management District has been declared a state nonattainment area for ozone; and

WHEREAS, the El Dorado County Air Quality Management District has developed a program for the expenditure of the increased fee to reduce air pollution from motor vehicles including the purchase of new school buses pursuant to the Lower Emission School Bus Program and other projects related to planning, monitoring, enforcement and other technical activities.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors of the El Dorado County Air Quality Management District hereby requests that the fee established under Health and Safety Code Section 44233 be increased by \$2.00 for a total of \$6.00 per fee paying registered motor vehicles in El Dorado County, commencing on October 1, 2006, and requests the California Department of Motor Vehicles to collect and distribute said fees pursuant to Section 9250.17 of the California Vehicle Code.

BE IT FURTHER RESOLVED that the El Dorado County Air Quality Management District shall use the above \$2.00 increase in fees to reduce air pollution from motor vehicles pursuant to the California Clean Air Act of 1988 (Chapter 1568) including the purchase of new school buses pursuant to the Lower Emission School Bus Program and other projects under AB 923 related to planning, monitoring, enforcement and other technical activities.
