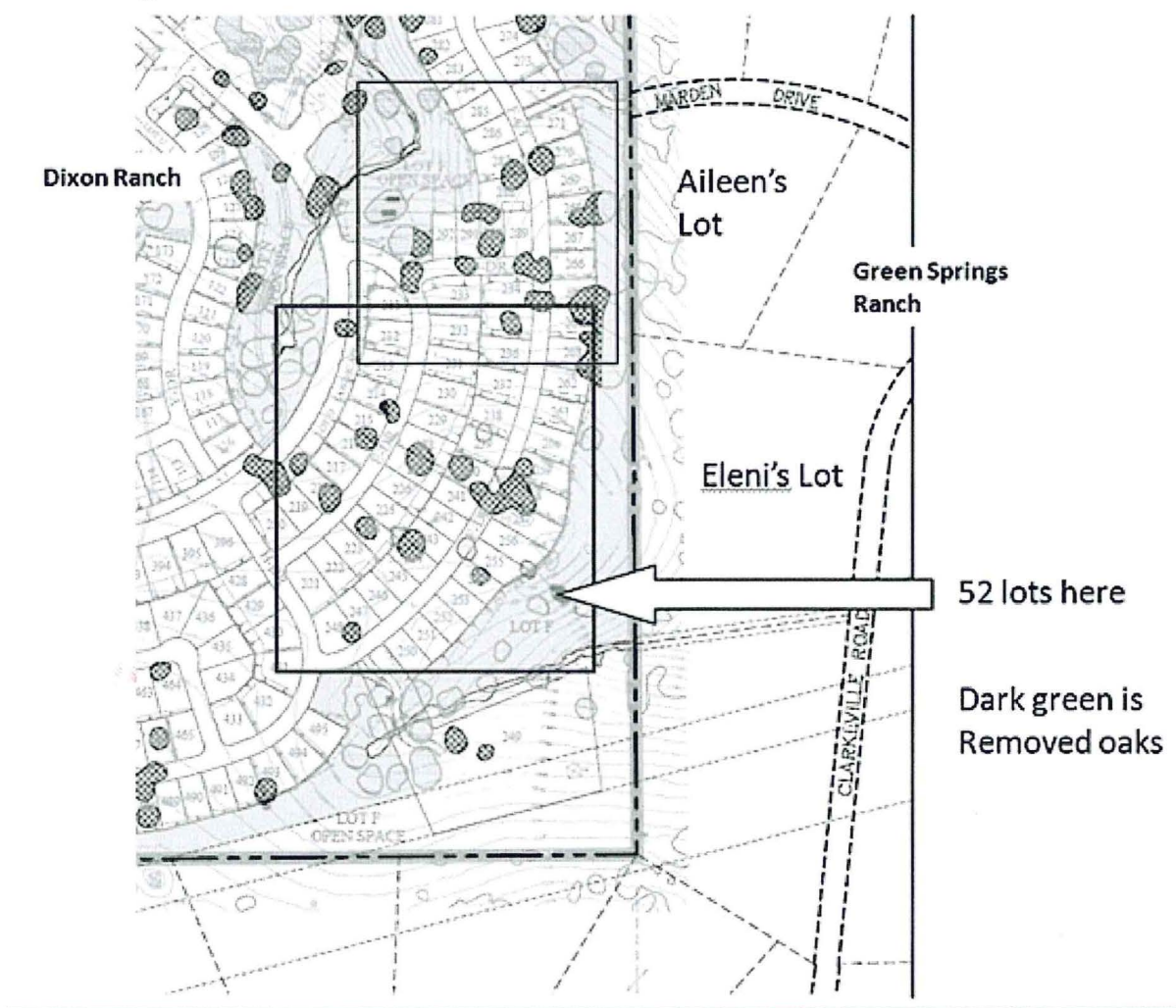

RE: Dixon EIR 60 day Extension Request.

I, as well as many people in the Community are asking for an extension to review this 2<sup>nd</sup> EIR that was released last month November 2014 and comments stated due in early Jan. over the Holidays. I've begun reading this immense EIR document and huge 500 plus page Appendices. Pages totaling well over 800 pages. These Mitigations in the Dixon EIR are seriously problematic with many clear issues not resolved. The public needs time to comment and show this to the Board. This project would have considerable effects on the whole circulation of El Dorado Hills. There are solutions for this area the Board needs time to hear the public's comments. I have requested a reasonable extension of at least 60 days due to the large EIR and supporting TIA being released over the Holidays and the volumous documentation it contains. Many people are voicing this same sentiment. El Dorado Hills is looking to your decision heard today to grant a reasonable extension of time. This is a very reasonable request. Please include my comment for request for a 60 day extension into record. The Board has always said it welcomes public comment and wants the participation of the public. Extending the comment period to a reasonable 60 days based on this very large and very complex project would show the public the Board supports the transparency of the planning process, good faith in public participation and give level access to public commenting.
