I understand there is a hearing on March 23rd regarding Villa Florentina's request to expand their special use permit to allow for longer hours, higher decibel/volume limits, and additional days for special events. I will not be able to attend the hearing, but am writing to express my objections to this request.

My husband and I frequently and regularly stay with friends who live on Carver Road. I have been quite ill for the last couple of years, and go there to rest and recover from chemotherapy and other treatments. I am probably there a couple of weeks per month during the Spring, Summer, and Fall. I generally find the environment healing and restorative. However, on Saturday nights, we can clearly hear all the amplified sound from VF, including music and voices. Even if we move our chairs to the farthest edge of the property, down by the river, and as far as possible from the event, we can still hear all the amplified sounds as clearly as if we were actually attending the event. It is hard for me to imagine how the guests can tolerate the current volume - it must be ear-shattering if you are right there.

For this reason, I object to any increase in volume, and, in fact, think the limits should actually be lower and be enforced consistently. If I can hear it so clearly a quarter mile away, then it certainly doesn't need to be as loud as it has been in the past. I am also opposed to expanding the hours or frequency of events involving amplified sound, since the volume is the main problem.

On the other hand, I haven't noticed traffic being a particular problem, and VF appears to provide ample parking. So, if they wanted to hold more events WITHOUT any sound amplification, that would be a different story. But blasting loud music and voices in this pastoral, residential neighborhood, and forcing the residents and their guests to listen to it, is beyond comprehension. These types of events would be more appropriate in the commercial areas of Coloma, not on this quiet stretch of Carver Road.

I am a State Park Peace Officer/Ranger assigned to Marshall Gold Discovery State Historic Park. I have been working here since February, 2006. I lived in a park residence from Sept 2006 to November 2013. Last summer I was very glad that I no longer live in the park. On many occasions while on closing patrol or getting ready to go home I could hear music coming from Via Florentina. In the summer season I usually work until 2100 hours. The locker room is located on the west side of Hwy 49 across the street from the sawmill replica adjacent to the maintenance yard and two park residences. Most of the time, the music and DJ were so loud that I could sing along with the music and clearly hear every word the DJ said. On one occasion I heard the DJ say, "They are saying we are too loud. So let me hear everyone scream!". Via Florentina is located across the river from the park and I do understand that with that proximity I expect to hear some noise from weddings and other events. However, I lived in the park when the previous owner started offering the property for events. I do not recall ever hearing the level of noise that I experienced last summer.

I have had multiple contacts with the wedding parties using Via Florentina and the owners. These contacts have all been a result of the groups having their wedding photos taken on park property or the Mt Murphy bridge. The owners have been given a copy of State filming laws as well as being advised in person and over the phone. Commercial photograph is prohibited on any State property unless a permit is obtained from the California Film Commission and the State Park where the filming is taking place. Via Florentina said that they advise their groups that they may not use park property, but I have personally seen them bring people over to park property in their golf cart. When they photograph on the bridge they are impeding traffic on a public roadway.
