- Veteran's Court: See "Commission Matters"
- CAL-VET: Effective November 11, 2015, DMV to offer "Veteran" marking on driver's licenses, indicating service in the US Armed Forces, in order to receive, visit our office and bring your DD-214 and complete the Veteran Status Verification Form.
- VA Regional Office: National statistics, 373,483 claims pending, 69,075 Notice Of Disagreements - 766 over 2-years old; 990 Appeals – 238 over 2 years old and average of 5 years to process. Oakland Regional Office 10,976 claims pending. Our office uses the American Legion as our "power of attorney" for the majority of claims to the VA. The VA Choice Card Program is designed to supplement the care received at the VA medical facility, not replace or limit that care.

- County Department Veteran Affairs: Today was the first day for the DMV driver's license designation; we have been very busy today. Unfortunately we are processing more death benefits lately. Federal VA ID Card is coming, cost and agency responsible is currently. Unknown.
- Veteran Memorial Building: Draft Facility Use Agreement for the Veterans Memorial Building, agreement between County and House Council, will be distributed to House Council and other designated persons for review and recommendations

Veteran Memorial Monument upkeep \$13,000; Student Resource Grant \$5,000; Veteran Care Snowline Hospice \$25,000; Veteran Mini Grant Program \$41,048; El Dorado County Department of Veteran Affairs Student Intern \$15,600, Folsom Lake College Veteran Education Transition Resource Center \$35,000; Lake Tahoe Community College Veteran Education Transition Resource Center \$5,000.

Motion to present to the Board of Supervisors their recommendation for budgeting \$139,648 of the Transit Occupancy Tax (TOT) for FY1516 breakdown as follows:

- Department of Veteran Affairs to add to the FY1516 budget \$15,600 to fund a part-time intern.
- For FY1516 to continue with the agreement with the El Dorado Community Foundation as follows: Veteran Memorial Monument Upkeep \$13,000; Student Resource Grant \$5,000; Veteran Care Snowline Hospice \$25,000; Veteran Mini Grant Program \$41,048; Folsom Lake College Veteran Education Transition Resource Center \$35,000; Lake Tahoe Community College Veteran Education Transition Resource Center \$5,000. For FY1617, we will explore other options.
- Todd Smith motion, Bud Brown second, all approved.

Discussion on the funding and reporting process for Folsom Lake College and the funding allotment contract language for services and programs, coordinate with Creighton Avila, add to December TOT agenda.

The mini-grant applications will be updated to include date of current cycle.

Veteran Memorial Building/Veteran House Council receives its own appropriation directly from the general fund.

- David Zelinsky – American Legion Service Officer – Update Vet court, nine are enrolled one has transition out. Judicial counsel form still under-utilized during the intake process at the jail. Bob Sweatt confirmed with me that there South Lake Tahoe does not have veterans court there anymore. The Vet Court Team

meets at the historical courthouse on Main Street, upstairs on the 2nd Monday of each month at 1:30, Judge Wagoner is a veteran, Todd Smith expressed interest to participate, Joel Wenberg is a graduate of Vet Court and expressed his gratitude for the opportunity to get his life in order. David Zelinsky expressed his thanks for the hard work the El Dorado County Department of Veteran Affairs does for veterans.
