AMENDMENT I TO LEASE # 198-L1011**

4354 Town Center Blvd., Suite 112, El Dorado Hills, California

THIS AMENDMENT I to Lease Agreement #198-L1011 dated April 27, 2010 (the "Lease"), by and between **TOWN CENTER EAST, L.P.** a California limited partnership, The Mansour Company, a California corporation, its General partner, hereinafter referred to as "Lessor," and the **COUNTY OF EL DORADO**, a political subdivision of the State of California, hereinafter referred to as "Lessee", is hereby amended a first time as follows:

WHEREAS, on April 27, 2010 a lease agreement ("Lease") was entered into between the **COUNTY OF EL DORADO**, a political subdivision of the State of California ("Lessee"), and **TOWN CENTER EAST, L.P.** a California limited partnership, The Mansour Company, a California corporation, its General Partner ("Lessor"), for that certain real property known as **4354 Town Center Blvd., Suite 112, El Dorado Hills, California** that is incorporated herein and made a part hereof by this reference; and

WHEREAS, on February 7, 2013 (Exercise of Option) Lessee, County of El Dorado, notified Lessor of the intent to extend the aforementioned Lease Agreement 198-L1011 for an additional one (1) year term; and

NOW, THEREFORE, it is mutually agreed that Lease Agreement #198-L1010 shall be amended a first time as follows:

- A. Paragraph 2, TERM**, Is hereby amended to extend the term of said lease for an additional one (1) year period. The new expiration date shall be April 30, 2014 subject however, to earlier termination as, hereinafter more particularly provided in Paragraph 19.
