FIRST AMENDMENT TO AGREEMENT FOR SERVICES #235-S1510

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Lessor mutually agree to amend the terms of the Agreement in this First Amendment to Agreement, as follows:

I. ARTICLE III, Compensation for Services, paragraphs two (2) and three (3) of the Agreement are amended in their entirety to read as follows:

Itemized invoices shall follow the format specified by County and shall reference this Agreement number on their faces.
