Staves have managed American Heart Association Programs for both Garden Valley and Georgetown Fire for over ten years. Their commitment to teaching the 'Chain of Survival' to the public is deserving of special recognition and commendation.
- e. Communication Operator (CO) Leah Van Meter from CAL FIRE is being commended on the manner in which she handled a 911 call that involved a heart attack patient. The person calling 911 was understandably scared and

shaken as she advised that her husband had just collapsed to the floor and was not breathing. CO Van Meter responded in a very calm and reassuring manner which in turn calmed the reporting party. CO Van meter then gave clear and specific instructions to the reporting party on how to perform CPR and continued to coach her through the event until the firefighter/paramedics (FFP) arrived 11 minutes later. The arriving FFP's found the patient's pulse and breathing had returned because of the CPR that had been performed by the reporting party. The FFP's credited the reporting party and CO Van Meter for saving the patient's life.

- f. Communication Operators Diane Grove and Donna Atwood are being commended for the 30 plus years of dedicated, highly skilled and professional services they have provided the citizens and first responders of El Dorado County. We congratulate them on their retirement and wish them the very best for the future.

Engineer/paramedic (E/P) Travis Parsons from Diamond Springs-El Dorado Fire Protection District is being commended for the exceptional skill and knowledge he has brought to the firefighter/paramedic profession in the position of Field Training Officer. E/P Parsons has taught numerous recruits and expanded our depth of highly trained field ready personnel.

Life-Saving Event Overview:

In November, 2015, Hannah Fiterre was walking through the parking lot of Union Mine High School when she came upon a man lying on the ground. The man, Mr. Ken Scanavino was not breathing and he had no pulse. Ms. Fiterre immediately called for help and for another person to call 911. Ms. Fiterre began administering CPR and was shortly thereafter joined by Ms. Mary Garecht.

Ms. Fiterre and Ms. Garecht continued to administer CPR until the arrival of firefighter/paramedics. The medics provided advanced life-support treatment and shocks from their defibrillator monitor. They then transported Mr. Scanavino to Marshall Hospital where he received additional advanced cardiac care. We are

happy to report Mr. Scanavino survived his heart attack and is recovering very well.

I had an opportunity to speak with the attending firefighter/paramedics and all praised Ms. Fiterre and Ms. Garecht for the exceptional manner in which they sought assistance and administered CPR. They attribute Mr. Scanavino's life-save to Ms. Fiterre and Ms. Garecht.

We would also like to thank Mr. Scanavino for proactively talking about his experience publicly and encouraging others to take CPR and first aid training. We, along with Mr. Scanavino, want to applaud the fantastic courage and superior CPR skills they brought to saving Mr. Scanavino's life.

Life-Saving Event:

The driver of a car became stranded in swift moving water that had over run a road. Firefighter/paramedics responded to the 911 call and immediately began to work as a team to reach and extricate the driver from the car and the swift moving water. Engineer/paramedic Greg Schwegler donned a dry suit and entered the water. While making his way to the vehicle, the vehicle began to move down stream along with the swift moving water. E/P Schwegler was able to get the driver out of the vehicle but she could not stand. E/P Schwegler carried the women and made his way to shore. We are commending the on-scene first responders who working in a team effort moved quickly and efficiently to save the driver's life. Those being commended include:
