A case can be made that the 26 mile Sacramento Placerville Transportation Corridor (SPTC) is an economic engine that has the potential to drive international attention to El Dorado County given enough capital. The model is in place, though at a smaller scale through the operation of El Dorado Western Railroad, the living history program of the El Dorado County and through actions that the Board of Supervisors have taken. It cannot be denied that El Dorado Trail is identified as a premier experience by both class 1 and mountain bikers, as well as walkers and equestrian users.

Spending is occurring. Families (locals, regional and even international) are making the purchases to experience these amenities unique to El Dorado County, therefore economic development is occurring. This effort can be expanded to a much greater degree with capital expenditure as this grant provides.

 In economics, the term [well-being] is used for one or more quantitative measures intended to assess the quality of life of a group, for example, in the capabilities approach and the economics of happiness. As with the related cognate terms 'wealth' and 'welfare', economics sources often contrast the state with its opposite. (Wikipedia)

The ability to provide the necessities, i.e. public safety, infrastructure, etc. makes for a higher quality of life and therefore happiness and well-being. These necessities lead to reduced concerns and improved mental health.

The importance of the SPTC has been expressed in different forums of discussion including the El Dorado County Fire Safe Council. As a 26 mile fire break, it provides the residents a comfort and deduction in apprehension about wildfire going unchecked without the possibility of control. This grant makes a capital investment to reduce risk and provide economic well-being, reducing the risk of unchecked wildfire.

- 3. Adam Smith (father of modern economics) defined four types of fixed capital (which is characterized as that which affords a revenue or profit without circulating or changing masters). The four types were:
  - a. useful machines, instruments of the trade;
  - b. buildings as the means of procuring revenue;
  - c. improvements of land; [and]
  - d. the acquired and useful abilities of all the inhabitants or members of the society.

Once the capital investment is made, all the work is done by volunteers.


Times are changing: technological, generational and international.

They want more than just a bed and a television. They want free Wi-fi, activities for themselves and for children, good food and good coffee. Some want accommodations for their dog.

We need hotels in strategic locations. We also need to implement our new policies with respect to our rural areas. The Sacramento Business Journal on June 10 led with the headline, "Appetite for agritourism is growing." We know that. The CEDAC Action Plan lists them:

Home-based business ordinance Expansion of Agricultural Districts Rural commerce zoning Ranch marketing on grazing lands Right to Farm ordinance aligned with state law Agricultural Homestays in rural lands Health Resorts and Retreat Centers Dude Ranches in permitted zoning



We cannot have a "rural atmosphere" unless we have a "rural economy. Right now, we have a sweet spot in our agricultural lands. Most of the farmers, grape growers, ranchers and vintners are local families who have put their hearts and financial investments into their businesses.
