

AGREEMENT FOR SERVICES #116-F1711  
AMENDMENT AMD I

This Amendment I to that Agreement for Services #116-F1711, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and El Dorado County Farm Trails Association, a non-profit organization duly qualified to conduct business in the State of California whose mailing address is P.O. Box 20, Placerville, CA 95667; (hereinafter referred to as "Grantee");

**RECITALS**

**WHEREAS**, Grantee has been provided funding by County to perform activities that encourage economic development in the County by supporting and promoting tourism, entertainment, business, and leisure travel activities through the County's Economic Development Program, in accordance with Agreement for Services #116-F1711, dated October 3, 2016, incorporated herein and made by reference a part hereof; and

**WHEREAS**, County has appropriated funding for the purpose of providing Economic Development Grants to private non-profit organizations and public agencies; and

**WHEREAS**, the funding provided herein will serve a public purpose and provide a valuable public benefit in that it will promote cultural activities, historical preservation activities, and/or promotional activities which enhance tourism and industry, and/or local community events which encourage a sense of community to the people of the County of El Dorado; and

**WHEREAS**, the parties agree the funding will be in conformity with all applicable federal, state and local laws and use of the funding shall be in conformity with the Economic Development Opportunity Grant Program.

**WHEREAS**, the parties hereto have mutually agreed to revise the activities to be provided by Grantee identified in Exhibit "A", hereby amending **ARTICLE 1 – Description of Project/Program/Event**; and

**WHEREAS**, the parties hereto have mutually agreed to extend the term of the Agreement through December 31, 2017, hereby amending **ARTICLE 2 – Term**; and

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #116-F1711 shall be amended a first time as follows:

1. **ARTICLE 1** is amended in its entirety to read as follows:

**Description of Project/Program/Event**

Grantee shall complete the project/program/event ("Project") described in Revised Exhibit "A," marked "Description of Project," incorporated herein and made by reference a part hereof. It is understood that funding provided by County is not intended to fully fund the Project. Grantee is responsible for securing other sources of funding necessary to fully fund and deliver the Project.

2. **ARTICLE 2** is hereby amended in its entirety to read as follows:  
**Term:** This Agreement shall become effective when fully executed by the parties hereto and shall cover the period of July 1, 2016 through December 31, 2017.
3. All references to Exhibit "A" shall be substituted by the Revised Exhibit "A" for all purposes in the Agreement.

The parties may mutually agree to extend the Agreement for one additional year. County shall notify Grantee at least sixty (60) days prior to the termination date of this Agreement if it does not intend to extend the Agreement.

Except as herein amended, all other parts and sections of that Agreement #116-F1711 shall remain unchanged and in full force and effect.
