

Dear Board of Supervisors, Item 50 concerns the CDA and the raising of fees charged to the public for services. Dear BOS, This is my second comment to the proposed fee increases. My previous comments still apply generally. No fees and tax increases until we have a annually balanced budget with revenues exceeding or equaling expenditures. County spending still needs massive cuts.

With respect to the airport fees I have three comments, First the airport provides much fire safety so it isn't there for just aircraft owners. During the King Fire, Placerville airport was extremely important to fighting that fire. It was the main base of air ops. The airport is a large County safety asset. Second, I have no problem with most of the fee increases except for the outrageous increase to the 1411 sf hangar ground lease. Why so much more than the other fees and Thirdly is vehicle parking. Does this apply to vehicles parked in your hangar which you are already paying for or to parking in your ground lease space when you are flying your airplane? Parking your car on other airport areas and not in your ground lease space is another issue.
