

RESOLUTION 241-2001

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO RESOLUTION AMENDING FEES FOR BURIALS AT COUNTY-OWNED PUBLIC CEMETERIES

WHEREAS, numerous public cemeteries are situated within the boundaries of the County of El Dorado; and

WHEREAS, the County receives periodic requests for interment services at said public cemeteries; and

WHEREAS, Section 8.20.090 of the County Ordinance Code provides for the establishment of a schedule of fees for services provided at public cemeteries; and

WHEREAS, the Board of Supervisors finds it in the best interest of the residents of the County to maintain a uniform Schedule of Fees to be charged for services provided at said public cemeteries;

NOW THEREFORE, the El Dorado County Board of Supervisors does hereby resolve:

A. The fees applicable to services provided at public cemeteries owned by the County of El Dorado are as follows:

| 1. Purchase of a Plot | \$ 600 each |
| 2. Opening & Closing of grave
*Single-depth non-cremated remains | \$ 950 per burial |
| 3. Opening & Closing of grave
*Double-depth non-cremated remains | \$1,100 first burial |
| 4. Opening & Closing of grave
*Double-depth non-cremated remains | \$ 950 second burial |
| 5. Opening & Closing of grave
*Cremated remains | \$ 295 per burial |
| 6. Additional charge to Open & Close on Saturday,
Sunday or Holiday; non-cremated remains | \$ 275 per burial |
| 7. Additional charge to Open & Close on Saturday,
Sunday or Holiday; cremated remains | \$ 100 per burial |
| 8. Release of Interest in Plot (transfer) | \$ 50 each plot |

* Includes Polymer Liner

- B. The Cemetery Director shall have authority to require payment of any additional fees for services deemed necessary in connection with interments or disinterments.

- C. Any changes in this Schedule of Fees shall be made by Resolution of the Board of Supervisors.


BE IT FURTHER RESOLVED, that a copy of this Resolution amending the Schedule of Fees shall be kept on file in the office of the County's Cemetery Director.


