



**RESOLUTION** 302-2001

**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO  
RESOLUTION CORRECTING OMISSION FROM RESOLUTION NO. 242-2001 APPROVED  
ON AUGUST 28, 2001 SETTING THE SCHEDULE OF FEES FOR THE GEORGETOWN  
CEMETERY ZONE OF BENEFIT #3 WITHIN COUNTY SERVICE AREA #9**

**WHEREAS**, the Board of Supervisors of the County of El Dorado formed County Service Area #9 pursuant to Title 3, Division 2, Part 2, Chapter 2.2 of the California Government Code; and

**WHEREAS**, the Board of Supervisors established the Georgetown Cemetery Zone of Benefit #3 on February 28, 1984 by Resolution No. 57-84; and

**WHEREAS**, Section 8.20.090 of the County Ordinance Code provides for the establishment of a schedule of fees for services provided at public cemeteries; and

**WHEREAS**, a schedule of fees for said cemetery zone was established by Resolution No. 260-94 and revised by Resolution No. 203-98, Resolution No. 069-99, and Resolution No. 242-2001; and

**WHEREAS**, due to a clerical error, the fee for opening and closing of a cremains plot grave (including liner) was inadvertently omitted from the approved schedule of fees; and

**WHEREAS**, it is necessary to correct the schedule of fees and add fees in the amount of Two Hundred Ninety Five Dollars (\$295) for said cemetery services;

**NOW THEREFORE**, the Board of Supervisors hereby resolves:

A. The schedule of fees applicable to services provided in the Georgetown Cemetery Zone of Benefit # 3 are hereby revised and corrected as follows:

Purchase of Full Plot	\$ 250.00
Endowment Care for Full Plot	\$ 200.00
Opening and Closing of Single Depth Full Plot Grave *	\$ 950.00
Opening and Closing of <i>First Burial</i> of Double Depth Full Plot Grave *	\$ 1,100.00
Opening and Closing of <i>Second Burial</i> of Double Depth Full Plot Grave *	\$ 950.00
Additional Charge for Opening and Closing of a Full Plot Grave on a Saturday, Sunday, or Holiday	\$ 275.00
Non-Resident Fee for Purchase of a Full Plot	\$ 400.00

Purchase of Cremains Plot	\$ 100.00
Endowment Care for Cremains Plot	\$ 100.00
Opening and Closing of Cremains Plot Grave *	\$ 295.00
Additional Charge for Opening and Closing of Cremains Plot Grave on a Saturday, Sunday, or Holiday	\$ 100.00
Non-Resident Fee for Purchase of a Cremains Plot	\$ 200.00
Release of Interest in Plot (transfer)	\$ 50.00

\* Include Polymer Liner

- B. The Cemetery Director, or his/her designee, shall have authority to require payment of any additional fees for services deemed necessary in connection with interments or disinterments.
- C. Any changes in this schedule of fees shall be made by Resolution of the Board of Supervisors.




