



**RESOLUTION NO. 097-2010**  
**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**  
**FIXING RATES AND CHARGES ON COUNTY AIRPORTS**  
**SUPERSEDING RESOLUTION NO. 232-2004**

WHEREAS, the County of El Dorado owns and operates Placerville and Georgetown Airports;

WHEREAS, pursuant to Section 18.04.100 of the El Dorado County Airport Ordinance, all fees, rates and charges shall be fixed by resolution of the Board of Supervisors.

WHEREAS, the current rates and charges were established in 2004 pursuant to Resolution No. 232-2004.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of El Dorado hereby establishes for the County Airports, administered by El Dorado County, the following fees, rates and charges.

Twin Engine & Small Helicopter	\$60.00
Heavy Twin Turbine (Cabin Class) & Medium Helicopter	\$83.00
Large Turbine (Non-transport) Jets	\$167.00
Large Turbine Helicopter	\$220.00

**Aircraft Visitor Parking (Rates per Night – 30 day Maximum):**

Single Engine	\$6.00
Twin Engine & Small Helicopter	\$7.00
Heavy Twin Turbine (Cabin Class) & Medium Helicopter	\$8.00
Large Turbine (Non-transport) Jets	\$15.00
Large Turbine Helicopter	\$20.00

**Aircraft Hangars:**

County Rental Hangars	\$150.00/Month
Single "T" Hangars Land Lease	\$636.00/Year
Twin "T" Hangars Land Lease	\$720.00/Year
Rectangular Hangars Land Lease (per square foot)	\$0.044/Month

Commercial Landing Fee (Twice Daily)	\$910.00/Year
Commercial, Undeveloped Land Lease (per square foot)	\$0.088/Month

Ground Lease Assignment Fee (Sale of Hangar)	\$250.00


All fees shall be effective July 1, 2010 and are subject to review on an annual basis.
