Dear Mr. Pabalinas:

The El Dorado Hills Community Services District (EDHCSD) would like to take this opportunity to comment on the above referenced map/topic. Serrano Associates, LLC has recently made several requests to El Dorado County for multiple project time extensions, as well as submitting for amendments to the Specific Plan and Zoning of projects.

During the El Dorado County Planning Commission Meeting held on March 23, 2017, the EDHCSD expressed concern related to these project extensions and amendments, and how these actions are directly affecting the submittal, processing and commitment to deliver required parkland in a timely manner. The EDHCSD has been exceptionally patient in resolving the remainder parkland dedication for the El Dorado Hills Specific Plan (a.k.a. Serrano).

The EDHCSD has been presented with a conceptual map amendment for J Lot H that depicts a plan that is acceptable in fulfilling the remainder park acreage required per the Specific Plan (approximately 12.5 acres). That proposed park site location provides a shape and orientation that would be amenable to planned acquisition and preservation of the greater Bass Lake area. Further delays on Village J Lot H will hinder a planned effort to preserve nearly 200 acres of open space and parkland that is becoming more and more scarce. Details on the acquisitions at/around Bass Lake cannot be described here, as the matters are currently considered confidential.

The EDHCSD is requesting that an application be made as soon as possible to amend the mapping and rezoning of the property identified as Village J Lot H to align with the conceptual map proposed by Serrano Associates, LLC, dedicating a final park site to the EDHCSD. This step is required prior to the EDHCSD moving forward with design and delivery of a park. At this time, the EDHCSD has solicited quotes and will be awarding landscape architecture work for conceptual design of other parkland in the

Bass Lake area, but would be remiss if the owner again attempts to relocate the final park site.

While it is tempting to request that the Planning Department, Planning Commission and County assist in resolving this matter prior to moving forward on any of the variety and multitude of applications made by Serrano Associates, LLC, the EDHCSD is taking this opportunity to inform you, in writing, of its position, as it relates to the readiness to secure the long-awaited remainder parkland in this Plan. This parkland is a priority, and should be treated as such.
