**AGREEMENT FOR SERVICES #316-S1611**

**AMENDMENT III**

This Amendment III to that Agreement for Services #316-S1611, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Mother Lode Van & Storage, Inc., a California Corporation duly qualified to conduct business in the State of California, whose principal place of business is 11255 Pyrites Way, Suite 400, Rancho Cordova, California 95670 (hereinafter referred to as "Contractor").

**RECITALS**

**WHEREAS**, Contractor has been engaged by County to provide moving services and modular furniture disassembly, inventory, removal, and reinstallation services on an "as requested" basis for the County facilities both on the East Slope and West Slope of El Dorado County, in accordance with Agreement for Services #316-S1611 dated January 26, 2016, Amendment I dated May 27, 2016, and Amendment II dated June 6, 2016, all incorporated herein and made by reference a part hereof; and

**WHEREAS**, the parties hereto have mutually agreed to revise Exhibit "A" – Fee Schedule to include additional services, supplies and/or rental rates.

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #316-S1611 shall be amended a third time as follows:

**ARTICLE III**

**Compensation for Services paragraph 3 is hereby replaced in its entirety with the following:**

For the purposes of this Agreement, the billing rate shall be billed in accordance with Exhibit "A" marked "Revised Fee Schedule", incorporated herein and made by reference a part hereof. Only permanent employees of Contractor are to be utilized unless prior written approval is granted by the County for the use of subcontractors.
