

AGREEMENT FOR SERVICES #339-S1311
AMENDMENT IV

This Amendment IV to that Agreement for Services #339-S1311, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and the Superior Court of California, County of El Dorado, a government entity, duly qualified to conduct business in the State of California, whose principal place of business is 2850 Fairlane Court, Suite 110, Placerville, CA 95667; (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to alternate dispute resolution program services of all civil limited and unlimited cases and family dissolution, legal separation, nullity and parentage disputes filed in El Dorado County, in accordance with Agreement for Services #339-S1311, date January 18, 2013, Amendment I, dated February 27, 2014, its Amendment II dated September 1, 2015, and its Amendment III dated March 4, 2016, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to increase the not to exceed amount and add rates for Family Law Facilitator to said Agreement, hereby amending **ARTICLE III – Compensation For Services**; and

NOW THEREFORE, the parties do hereby agree that Agreement for Services #339-S1311 shall be amended a fourth time as follows:

ARTICLE III is amended in its entirety to read as follows:

Compensation for Services: For services provided herein, County agrees to pay Contractor monthly in arrears and within thirty (30) days following the County's receipt and approval of invoice(s) identifying services rendered. County shall pay for 49% of the actual costs based on the rates specified below. Actual costs are the billing rates specified below for the personnel providing services and are defined for purposes of this Agreement as the salary and all payroll related expenses, such as cost of benefits, workers compensation costs, and payroll taxes, and all telephone and related communication expenses.
