# AGREEMENT FOR SERVICES #165-S1511

#### AMENDMENT I

This Amendment I to that Agreement for Services #165-S1511, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Capital Engineering Consultants, Inc., a California Corporation duly qualified to conduct business in the State of California, whose principal place of business is 11020 Sun Center Drive, Suite 100, Rancho Cordova, California 95670 (hereinafter referred to as "Consultant").

### RECITALS

**WHEREAS**, Consultant has been engaged by County to provide engineering services for the walk-in refrigerator/freezer replacement in the main kitchen, electrical systems upgrade, and mechanical systems upgrade projects at the Placerville Jail for the County of El Dorado's Facilities Division, in accordance with Agreement for Services #165-S1511 dated August 29, 2016, incorporated herein and made by reference a part hereof; and

**WHEREAS**, the parties hereto have mutually agreed to extend term of said Agreement, hereby amending **ARTICLE II – Term**.

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #165-S1511 shall be amended a first time as follows:

## **ARTICLE II** is hereby replaced in its entirety to read as follows:

**Term:** This agreement shall become effective upon final execution by both parties hereto and shall cover, as amended, the period of August 29, 2014 through August 28, 2018.

Except as herein amended, all other parts and sections of that Agreement #165-S1511 shall remain unchanged and in full force and effect.
